

Statement from The Congregation of The Sisters of Mercy – Response to The NBSCCCI Review of Child Safeguarding Practice

The Congregation of the Sisters of Mercy invited the National Board for the Safeguarding of Children in the Catholic Church in Ireland (NBSCCCI) to audit their safeguarding policy and practice in June/July 2015. The review is now complete; the Congregation accepts in full its recommendations and welcomes the publication of the NBSCCCI Review today. The Congregation will implement the Audit recommendations as outlined in the review in the coming weeks/months.

The Sisters of Mercy again sincerely apologise to individuals who have suffered abuse and/or the betrayal of trust by some of our Sisters in past years. We uphold the primary importance of safeguarding children. We renew our commitment to work in partnership with the NBSCCCI and civil authorities to ensure that where we live and minister are safe environments for children. We welcome the fact that the NBSCCCI has found that our present child safeguarding systems are most satisfactory and we are determined that this continues to be so in all our various ministries into the future.
